TO THE MEMBERS OF THE CITY COUNCIL

Dear Councillor,

Annual Council and First Meetings – Wednesday, 16th May 2018

In line with previous practice, the first meetings of the Cabinet and Council Committees will be held in the Council Chamber on the afternoon of Wednesday 16th May 2018, for the purposes of appointing the Chairs and Deputy Chairs, as appropriate, and to fix the date and time of the meetings, together with any procedural matter relating thereto.

The Cabinet will have an additional item of business to consider, relating to changes to full Council meetings, which will result in a recommendation being made for consideration by the Council. Any permanent change to Council Procedure Rules requires a recommendation of the Cabinet and the proposed changes, to commence from the 6th June Council meeting, will involve permanent changes to the Council Procedure Rules in the Council's Constitution. Accordingly, it is proposed to adjourn the Annual Meeting of the Council prior to consideration of item of business number 9 on its agenda (Arrangements For Council Meetings In The Municipal Year 2018-19), and then hold the first meetings of the Cabinet and Council Committees, following which the meeting of the Council will reconvene to consider item 9 along with the recommendation made by the Cabinet.

I enclose with this letter, a list showing the proposed order for the first meetings, together with the draft agendas, which will be held immediately following one another and without a break. With the exception of the meeting of the Cabinet (which will be chaired by the Leader of the Council), the Lord Mayor will occupy the Chair and the Members of the Council will be required to remain in their seats throughout the whole of the proceedings.

In addition to fixing the date and time of its meetings, the meeting of the Cabinet will consider the report of the Executive Director, Resources (which is published with the agenda for the Annual Meeting of the Council) on proposed changes to full Council meetings. The Cabinet will move, and vote on, a Motion to approve or amend the recommendations in the report. The resolution of the Cabinet will then be produced and circulated in the Chamber for consideration at the reconvened Annual Meeting of the Council.



To facilitate the transaction of the business of the Council Committees, the Lord Mayor will announce at the start of each meeting, the name of the mover and seconder of the composite motion to determine the business as detailed in the agenda. The names of the mover and seconder of the composite motion will be drawn from the Members of the particular Committee. The Lord Mayor will put the motion upon which the Members of the Committee concerned will vote. In the event of any questions arising upon any item on the agenda for a particular Committee, only the members of that Committee are permitted to participate in the discussion.

Details of the proposed memberships of the Cabinet and Council Committees etc., which is being prepared in consultation with the Party Whips, will be made available to all Members of the Council at the meeting.
