Report of the Chief Licensing Officer



ADVICE TO MEMBERS ON DECLARING INTERESTS AT MEETINGS

If you are present at a meeting of the Council, of its executive or any committee of the executive, or of any committee, sub-committee, joint committee, or joint sub-committee of the authority, and you have a **Disclosable Pecuniary Interest** (DPI) relating to any business that will be considered at the meeting, you must not:

- participate in any discussion of the business at the meeting, or if you become aware of your Disclosable Pecuniary Interest during the meeting, participate further in any discussion of the business, or
- participate in any vote or further vote taken on the matter at the meeting.

These prohibitions apply to any form of participation, including speaking as a member of the public.

You **must**:

- leave the room (in accordance with the Members' Code of Conduct)
- make a verbal declaration of the existence and nature of any DPI at any
 meeting at which you are present at which an item of business which affects or
 relates to the subject matter of that interest is under consideration, at or before
 the consideration of the item of business or as soon as the interest becomes
 apparent.
- declare it to the meeting and notify the Council's Monitoring Officer within 28 days, if the DPI is not already registered.

If you have any of the following pecuniary interests, they are your **disclosable pecuniary interests** under the new national rules. You have a pecuniary interest if you, or your spouse or civil partner, have a pecuniary interest.

- Any employment, office, trade, profession or vocation carried on for profit or gain, which you, or your spouse or civil partner undertakes.
- Any payment or provision of any other financial benefit (other than from your council or authority) made or provided within the relevant period* in respect of any expenses incurred by you in carrying out duties as a member, or towards your election expenses. This includes any payment or financial benefit from a trade union within the meaning of the Trade Union and Labour Relations (Consolidation) Act 1992.

*The relevant period is the 12 months ending on the day when you tell the Monitoring Officer about your disclosable pecuniary interests.

- Any contract which is made between you, or your spouse or your civil partner (or a body in which you, or your spouse or your civil partner, has a beneficial interest) and your council or authority –
 - under which goods or services are to be provided or works are to be executed; and
 - which has not been fully discharged.

- Any beneficial interest in land which you, or your spouse or your civil partner, have and which is within the area of your council or authority.
- Any licence (alone or jointly with others) which you, or your spouse or your civil
 partner, holds to occupy land in the area of your council or authority for a month
 or longer.
- Any tenancy where (to your knowledge)
 - the landlord is your council or authority; and
 - the tenant is a body in which you, or your spouse or your civil partner, has a beneficial interest.
- Any beneficial interest which you, or your spouse or your civil partner has in securities of a body where -
 - (a) that body (to your knowledge) has a place of business or land in the area of your council or authority; and
 - (b) either -
 - the total nominal value of the securities exceeds £25,000 or one hundredth of the total issued share capital of that body; or
 - if the share capital of that body is of more than one class, the total nominal value of the shares of any one class in which you, or your spouse or your civil partner, has a beneficial interest exceeds one hundredth of the total issued share capital of that class.

If you attend a meeting at which any item of business is to be considered and you are aware that you have a **personal interest** in the matter which does not amount to a DPI, you must make verbal declaration of the existence and nature of that interest at or before the consideration of the item of business or as soon as the interest becomes apparent. You should leave the room if your continued presence is incompatible with the 7 Principles of Public Life (selflessness; integrity; objectivity; accountability; openness; honesty; and leadership).

You have a personal interest where -

- a decision in relation to that business might reasonably be regarded as affecting
 the well-being or financial standing (including interests in land and easements
 over land) of you or a member of your family or a person or an organisation with
 whom you have a close association to a greater extent than it would affect the
 majority of the Council Tax payers, ratepayers or inhabitants of the ward or
 electoral area for which you have been elected or otherwise of the Authority's
 administrative area, or
- it relates to or is likely to affect any of the interests that are defined as DPIs but are in respect of a member of your family (other than a partner) or a person with whom you have a close association.

Guidance on declarations of interest, incorporating regulations published by the Government in relation to Disclosable Pecuniary Interests, has been circulated to you previously.

You should identify any potential interest you may have relating to business to be considered at the meeting. This will help you and anyone that you ask for advice to fully consider all the circumstances before deciding what action you should take.

In certain circumstances the Council may grant a **dispensation** to permit a Member to take part in the business of the Authority even if the member has a Disclosable Pecuniary Interest relating to that business.

To obtain a dispensation, you must write to the Monitoring Officer at least 48 hours before the meeting in question, explaining why a dispensation is sought and desirable, and specifying the period of time for which it is sought. The Monitoring Officer may consult with the Independent Person or the Council's Audit and Standards Committee in relation to a request for dispensation.



1.0 PURPOSE OF REPORT

1.1 To consider an application for the grant of a premises licence made under section 17 of the Licensing Act 2003.





As a resident of Number Dore, Sheffield S17 I, I wish to object to the licensing application for the sale of alcohol and to enable regulated entertainment between the hours of 11.00 and 02.00.

The main reasons for opposing the application:

- 1. Noise from the events (occasionally already a lot of loud music being played).
- 2. Traffic/congestion/lots of cars is dangerous for pedestrians and road users along Ashfurlong Road (there is an exit route with a gate from the sports club leading to Ashfurlong Road). Getting in and out of our driveways is chaotic and dangerous.
- 3. People park cars all over Ashfurlong Road and Cavendish Avenue, which increases the risks of accidents especially when turning along a sharp bend.
- 4. There is no public transport during the night and people who come to the sports club will need to drive/take a taxi, which will create more noise and disorder in this residential area and may cause more problems of drunk driving.

We write with reference to the application by Abbeydale Sports Ltd to allow the sale of alcohol up to 02.00 hours daily. We object to the extension since it will result in an unacceptable increase in late night antisocial behaviour and noise if granted. There are already late night incidents occurring and this extension will no doubt increase these into the early hours of the morning, causing disturbance to our home and all the homes which back onto or overlook the exit from the Club onto Ashfurlong Road.

The gate at the back of the Club has recently been left permanently open, against current planning restrictions. This has certainly caused nuisance and a safety hazard due to the increase in traffic on a dirt track with a narrow exit. Any approval of the licence must agree to maintain the current situation of access down the exit track only for emergency vehicles and a limited number of major sporting events. Activity at the sports club's new restaurant must not be included as part of the list of major events for which access via the entry on Ashfurlong Road is allowed. Nor should it be allowed on Bank Holidays or other days as specified on the application when it will similarly be unsafe and cause disturbance.

APPLICATION BY THE ABBEYDALE SPORTS CLUB LIMITED TO THE LICENSING AUTHORITY OF SHEFFIELD CITY COUNCIL

We are writing to object to the application made by the Abbeydale Sports Club Limited to the Licensing Authority of the Sheffield City Council for a Premises Licence for the Abbeydale Sports Club, Abbeydale Road South, Dore, Sheffield S17 3LJ.

The Application is to enable the sale of alcohol between 11.00hrs and 02.00hrs daily.

The basis of our objection is as follows:-

1. that extending the opening hours will exacerbate an existing problem of nuisance and increase the noise suffered by residents living at the lower end of Ashfurlong Road and Ashfurlong Park associated with the access track between the top car park of the Abbeydale Sports Club and Ashfurlong Road.

- 2. The club is permitted by the council to use the track just 24 times per year but it unfortunately fails to abide by this rule and leaves the gate open and unlocked almost permanently resulting in vehicles driving up and down the track causing a serious health and safety risk for very young adults (11-14 years generally) who walk along the track not expecting vehicles and with nowhere to stand out of the way of them as well as spoiling everyone's quiet and peaceful enjoyment of their gardens which back directly onto the track. We do not believe that the club is therefore capable of abiding by rules and fully expect drunken and loud people and vehicles to drive up and down the track very late at night including taxis as a result of the proposed licence and we also expect vandalism and damage to property (fences) down the track. The track is already used by youngsters to smoke drugs and generally make a nuisance of themselves (this is not the clubs fault of course) but we expect that the licence will exacerbate these issues. You can imagine drunken individuals singing and being noisy along the track on their way home or on their way to cars parked on ashfurlong road out of view so that they can drink and drive.
- 3. If the Licensing Authority decides to grant the application for extended hours then in our opinion the use of the access track should be specifically excluded as well as a specific rule which prohibits the use of the track by either vehicles or pedestrians and requires a locked gate at both ends of the track. There are residential properties abutting the track and where the track meets Ashfurlong Road. There are no residential properties in the immediate area where the main Abbeydale Club entrance meets Abbeydale Road South.
- 4. It seems to us to be entirely unusual and unacceptable to have a licence until 2AM in an area just a stones throw (100m from bedroom windows) from many residential properties. At least at present the booming noise from parties and events ends at 11pm.
- 5. Please keep our contact details entirely confidential.

As residents of ______, Dore, Sheffield, ______, we wish to object to the above licensing application which seeks to extend the licence for the sale of alcohol and to enable Regulated Entertainment between the hours of 11.00 and 02.00 daily.

The Abbeydale Sports Club is situated in a highly residential area surrounded by many family houses. Many of these houses are in close Page 35

proximity to and overlook the sports club. There is also an apartment block situated directly alongside the sports club's car park.

Our main reason for opposing the application for increased licensing and Regulated Entertainment hours, is the inevitability of noise nuisance and antisocial behaviour, daily until 2am. We already hear a lot of loud music and noise from events held at the club during the day. It is our understanding that the licence application for vastly extending the hours, is a consequence of the plan to change part of the clubhouse into a restaurant / banqueting venue. We understand that this has no connection to the sports facilities offered at Abbeydale, in fact it is a separate venture. Sporting activities do not generally require a 2am licence!

Many of the local houses (including ours and all those in Ashfurlong Park) were, we understand, built on land originally owned by Abbeydale Sports Club. We believe there are more plans afoot to build quite a few new family houses on the club's open air tennis courts thus increasing the number of residents likely to be negatively affected by these proposed changes to the licensing hours.

There is a small exit route into Ashfurlong Road with a top gate from the rear of the sports club, for vehicles and pedestrians, situated just a few yards from our house in Ashfurlong Road. When the Abbeydale Sports Club is hosting an event, Ashfurlong Road frequently becomes heavily congested with vehicles trying to access the premises. An example of this was on Tuesday 10th July 2018 when the club hosted a Schools Sports event. Ashfurlong Road was chaotic for quite some time during the day. There is a sharp bend nearby and the situation appeared to be extremely dangerous. Getting out of our driveway was almost impossible as it was for neighbouring residents. If the licensing hours are extended until the early hours, we anticipate cars and taxis disturbing us and our neighbours well into the night.

We believe that the type of licence that is being applied for may be suitable for a city centre venue but certainly not for a sports club set in a quiet, residential village. Dore is known for its excellent quality of life and this application represents a real threat both from noise nuisance and from the increase possibility of crime and disorder. In our experience, people who have been consuming alcohol until 2am are not usually concerned about

disturbing neighbours with noise and antisocial behaviour, which is why we believe only a city centre venue is suitable for such extensive hours.

This emailed representation is made in accordance with the agreement with the Licensing Authority on the 18th October 2006 to accept representations by email.

I have the following representation to make with regards to Public Nuisance for the application for a new grant of a Premises Licence for the above premises.

The proposal to have outdoor music (both Live and Recorded) means there is an enhanced potential for licensed activity, amplified sound and noise from people at the premises to give rise to complaints relating to public nuisance. In particular I am concerned that nearby residents will potentially be affected by excessive noise disturbance from loud amplified music and noise from people throughout the duration of events with outdoor music, especially as the proposal is to have outdoor music until 2am on every day of the week.

Having loud amplified music outdoors is an inherently noisy activity and care needs to be taken to ensure that nearby residents are protected from excessive noise prior to and during the events.

I have spoken to Tim Shield@ John Gaunt's and explained my concerns, but I have not heard back so will have to object to the application as it currently stands so I don't miss the deadline. 





Right of attendance, assistance and representation



15. Subject to regulations 14(2) and 25, a party may attend the hearing and may be assisted or represented by any person whether or not that person is legally qualified.

Representations and supporting information

- 16. At the hearing a party shall be entitled to
 - (a) in response to a point upon which the authority has given notice to a party that it will want clarification under regulation 7(1)(d), give further information in support of their application, representations or notice (as applicable),
 - (b) if given permission by the authority, question any other party; and
 - (c) address the authority

Failure of parties to attend the hearing

- 20. (1) If a party has informed the authority that he does not intend to attend or be represented at a hearing, the hearing may proceed in his absence.
 - (2) If a party who has not so indicated fails to attend or be represented at a hearing the authority may:—
 - (a) where it considers it to be necessary in the public interest, adjourn the hearing to a specified date, or
 - (b) hold the hearing in the party's absence.
 - (3) Where the authority holds the hearing in the absence of a party, the authority shall consider at the hearing the application, representations or notice made by that party.
 - (4) Where the authority adjourns the hearing to a specified date it must forthwith notify the parties of the date, time and place to which the hearing has been adjourned.

Procedure at hearing

- 21. Subject to the provisions of the Regulations, the authority shall determine the procedure to be followed at the hearing.
- 22. At the beginning of the hearing, the authority shall explain to the parties the procedure which it proposes to follow at the hearing and shall consider any request made by a party under regulation 8(2) for permission for another person to appear at the hearing, such permission shall not be unreasonably withheld.
- 23. A hearing shall take the form of a discussion led by the authority and cross-examination shall not be permitted unless the authority considers that cross-examination is required for it to consider the representations, application or notice as the case may require.
- 24. The authority must allow the parties an equal maximum period of time in which to exercise their rights provided for at regulation 16.
- 25. The authority may require any person attending the hearing who in their opinion is behaving in a disruptive manner to leave the hearing and may
 - (a) refuse to permit that person to return, or
 - (b) permit him to return only on such conditions as the authority may specify, but such a person may, before the end of the hearing, submit to the authority in writing any information which they would have been entitled to give orally had they not been required to leave.

Regulation 8



- (1) A party shall give to the authority within the period of time provided for in the following provisions of this regulation a notice stating
 - (a) whether he intends to attend or be represented at the hearing;
 - (b) whether he considers a hearing to be unnecessary
- (2) In a case where a party wishes any other person (other than the person he intends to represent him at the hearing) to appear at the hearing, the notice referred to in paragraph (1) shall contain a request for permission for such other person to appear at the hearing accompanied by details of the name of that person and a brief description of the point or points on which that person may be able to assist the authority in relation to the application, representations or notice of the party making the request.
- (3) In the case of a hearing under -
 - (a) section 48(3)(a) (cancellation of interim authority notice following police objection), or
 - (b) section 105(2)(a) (counter notice following police objection to temporary event notice),

the party shall give the notice no later than one working day before the day or the first day on which the hearing is to be held.

- (4) In the case of a hearing under
 - (a) section 167(5)(a) (review of premises licence following closure order),
 - (b) paragraph 4(3)(a) of Schedule 8 (determination of application for conversion of existing licence), paragraph 16(3)(a) of Schedule 8 (determination of application for conversion of existing club certificate)
 - (c) paragraph 26(3)(a) of Schedule 8 (determination of application by holder of justices' licence for grant of personal licence),

the party shall give the notice no later than two working days before the day or the first day on which the hearing is to be held.

(5) In any other case, the party shall give the notice no later than five working days before the day or the first day on which the hearing is to be held.

<u>Licensing Act 2003 – Hearing Procedure – Regulation 7 (1)</u>



- 1. The hearing before the Council is Quasi Judicial.
- 2. The Chair of the Licensing Committee will introduce the Committee and ask officers to introduce themselves.
- 3. The Chair will ask the applicants to formally introduce themselves.
- 4. The Solicitor to the Committee will outline the procedure to be followed at the hearing.
- 5. Hearing Procedure:-
 - (a) The Licensing Officer will introduce the report.
 - (b) Questions concerning the report can be asked both by Members and the applicant.
 - (c) The Licensing Officer will introduce in turn representatives for the Responsible Authority and Interested Parties who will be asked to detail their relevant representations.
 - (d) Members may ask questions of those parties
 - (e) With the leave of the Chair the applicant or his representative may cross examine the representatives of the Responsible Authorities and Interested Parties.
 - (f) The applicant/licensee (or his/her nominated representative) will then be asked to:-
 - (i) detail the application;
 - (ii) provide clarification on the application and respond to the representations made.
 - (g) The applicant/licensee (or his/her nominated representative) may then be asked questions by members and with the leave of the Chair from the other parties present.
 - (h) The applicant will then be given the opportunity to sum up the application.
 - (i) The Licensing Officer will then detail the options.
 - (j) There will then be a private session for members to take legal advice and consider the application.
- 6. The decision of the Licensing Committee will be given in accordance with the requirements of the Licensing Act 2003 and regulations made there under.
- NB: 1) At any time in the Licensing Process Members of the Committee may request legal advice from the Solicitor to the Committee. This advice may be given in open session or in private.
 - 2) The Committee Hearing will be held in public unless and in accordance with the Regulations the Committee determine that the public should be excluded.
