8. What action have you taken as the Sheffield City Council representative on the SCR Combined Authority due to that Authority being issued with a qualified concern over its statement of accounts about value for money?

The auditor gives two opinions. One is on the finances of the SCR, which are based on Sheffield City Council providing its own systems and staff (including the S151 officer), and these were given a completely clean bill of health. The second is on the SCR's governance and the qualified opinion here reflects the fact that the SCR's governance is relatively new and still maturing. The SCR Leaders have given their support to a revised Governance and Assurance Framework to be submitted to Government in February and was signed off at Monday's meeting.

9. In response to a public question at the meeting of full Council on 7th December, 2016, you stated that you had never said "that the decision in respect of Rustlings Road had been taken out of the Council's hands". Do you still stand by these words?

7. As part of a potential new contract for the Energy Recovery Facility (ERF), the paper to Cabinet of 18th January, 2017 states "The business drivers are to minimise risk and maximise income over the life of the asset" Does this mean extending the range of potential customers who could use the ERF if so who and what geographic area would this be extended to?

The report explains the characteristics of neighbourhoods where shared bins may be beneficial. We are clear there will need to be local consultation before any such scheme is trialled.

Section 2.5 sets out the new capacity allocation that will be provided once the new recycling service has been introduced and the blue box has been replaced with a 240 litre brown bin. The standard allocation will be based on the 1-5 resident level, with larger households able to apply for additional capacity as set out in section 1.3.11 of the [Waste Management Policy](#) document.

The changes will mean that large households will receive additional recycling capacity and not just general waste capacity, therefore helping to increase recycling performance.

As per the Waste Services Review report, the successful tenderer to operate and maintain the Energy Recovery Facility will be responsible for sourcing waste for the plant. It will be for the tenderer to assess if they would seek to change the existing permissions for the Energy Recovery Facility.

Questions of Councillor Adam Hanrahan to Councillor Bryan Lodge (Cabinet Member for Environment)

1. What actions have (a) you, (b) Sheffield City Council and (c) Amey, undertaken with regard to the memorial trees since the last full Council meeting?

All parties have been involved in highlighting a "new year new start" approach to trees that you will have seen in the media. This will mean working in a clear, transparent and collaborative way, and working to regain the trust of people in Sheffield. We have set up a Cross Party Member Working Group to look

at the Western Road First World War Memorial. This Group will work with War Memorials Trust and the local community to make fitting and long-lasting tributes to those who gave their lives for this country. We have also extended their remit to include other tree memorial streets at Frecheville, Crookesmoor, Meersbrook and Springvale Road.

2. When do you expect the Independent Tree Panel (ITP) report for Western Road being made available to yourself and Sheffield City Council?

As the Panel is independent of the Council, I am unable to say when they will provide any advice to us, but when we receive it, we will publish it on our web site.

3. Will you agree to share that report with me as soon as it becomes available to you?

Yes.

4. Have you undertaken a site visit to the trees on Western Road?

I have visited Western Road on a number of occasions and am aware of the trees, their commemoration of WW1, the plaque and the street itself.

5. Did you approve the initial plans to fell trees on Western Road?

The initial plans were drafted up by tree and highway experts to ensure that the Council complies with its legal duties. I have committed myself and the Council to working with interested parties to find a solution that is acceptable to all.

6. What impact will ending the Veolia Waste Management contract have on the annual red sack scheme carried out in the summer?

None.
Veolia will continue to be instructed under current arrangements.
Any new service specification will include the option for additional resource deployment, such as the red sack scheme.

Questions of Councillor Paul Scriven to Councillor Bryan Lodge (Cabinet Member for Environment)

1. What information will be collected and held by using RFID chips in bins under any new contracts?

The RFID chips, when combined with weighing equipment on the vehicles will record the location of the bin and the weight of material collected.
RFID chips will be fitted to shared

bins (flats and maisonettes) only.

2. Who will hold the data that is collected and what purposes will it be used for?

The data will be held by the Contractor and will be available to the Council.

The information will enable checks to be carried out to ensure that all bins are emptied at a location and that none have gone missing/had a missed collection. Collecting the weights of both the general waste and recycling collected at a location will allow for targeted education and communications to take place, helping residents to get the most from their waste and recycling services.

3. Who will be the legal owner of data collected from RFID chips in bins?

Sheffield City Council.

4. What opt in or opt out arrangements will local residents have on the collection of data associated with their household via RFID chips in their bins?

Because no information will be attributable to a specific household (the data will relate to the group of households sharing the bins provided) and due to the benefits and efficiencies associated with using the chips in terms of allowing for targeted communications, and understanding if bins are missed and if bins have gone missing, there will be no opt out option available.

5. Why is emptying of a bin conditional on having a RFID chip inserted after a given date?

We require the use of RFID chips to realise the benefits and efficiencies associated with using the chips in terms of allowing for targeted communications, and understanding if bins are missed and if bins have gone missing.

6. What is the cost of retro fitting bins with a RFID chip?

This information will be provided as part of the re-procurement process, however, as this information will be commercially sensitive, we will be unable to make this information available.

Questions of Councillor Rob Murphy to Councillor Bryan Lodge (Cabinet Member for Environment)

1. How much is the financial penalty of ending the Veolia waste contract early?

As discussed with the Shadow Cabinet when Officers presented the Waste Services Review report, the costs of ending the Veolia contract is currently commercially confidential. It is not in the public interest for Veolia to know our commercial strategy.
2. What, if any, are the long-term liabilities that the Council will retain after the end of the Veolia waste contract?

The Council has always retained the Duty of Care for the provision of waste services.
The sites provided to Veolia under the integrated waste contract, including the Energy Recovery Facility, will revert back to the Council.
3. What are the reasons for not bringing the whole service back in house?

The pros and cons together with the financial implications of the options to outsource, insource or alternative delivery model such as Teckal, are analysed within the Cabinet report: Waste Services Review.
4. Will the Administration ensure that any new contracts are open to public scrutiny?

As now, the contracts will be available, though some commercially confidential information may be redacted. The contracts will be awarded through the appropriate procurement methodology to uphold fairness in evaluation and award. The Council will continue to publish all expenditure over £250.

Question of Councillor Cliff Woodcraft to Councillor Mazher Iqbal (Cabinet Member for Infrastructure and Transport)

At the meeting of Full Council on 5th October, 2016, a petition regarding a crossing on Hangingwater Road was referred to the Cabinet Member for Infrastructure and Transport to consider what can be done to add to the road safety measures in and around Hangingwater Road. What progress have you made on this?

Recent progress has included erecting school warning signs, lengthening times the street lighting is on in the area, as well as putting up a Speed Indication Device (which provides a visual reminder of speeds to a driver) on Hangingwater Road. Hangingwater Road is also included in the Greystones and Whirlow 20mph zone, the construction of which is due to start on site later in the year.

Larger crossing schemes are prioritised, then constructed with the Streets Ahead Programme (SAP), with the aim of benefitting from reduced disruption and costs. The core investment period of the SAP ends in December, 2017, but the programme will continue. No decision has yet been made on how best to link the delivery of schemes on the request list with the ongoing maintenance programme after 2017. Therefore, no further work has been undertaken on developing a crossing on Hangingwater Road.

Questions of Councillor Ian Auckland to Councillor Mazher Iqbal (Cabinet Member for Infrastructure and Transport)

1. Does the Cabinet Member have any proposals to reduce the length of his list of outstanding highway requests?

The outstanding highway request list is made up of both smaller 'opportunity' schemes (such as a programme of dropped crossings, tactile paving and new handrails), and a programme of larger 'enhancement' schemes such as pedestrian crossings. Both programmes currently have approved budgets that are higher in 2017/18 than in 2016/17.

schemes actually delivered, or expected to be delivered?

Streets Ahead programme.

In the current financial year, Amey are working in around 20 zones. Each zone is inspected by Officers to ensure that works on the request lists compliment the work that Amey are already planning. If so, they are prioritised for construction. Although the numbers differ widely by zone, it is estimated that an average of six locations from the small scheme request list are implemented in each zone. This equates to around 120 locations in the year.

In terms of 'enhancement' schemes, the following are planned to have been delivered by the end of the financial year: Gleadless Road zebra crossing, two pedestrian crossing improvements on Wilkinson Street and new pedestrian islands on Southey Green Road. In addition, the following schemes (part funded in 2015/16) will have been completed – new pedestrian crossing facility at the Owler Lane/Barnsley Road traffic lights and an improved pedestrian crossing facility on Harcourt Road on the busy Crookes Valley Road walking route.

3. In the previous financial year, with reference to the list of outstanding highway requests, please list the schemes actually delivered?

Both smaller 'opportunity' and larger 'enhancement' schemes are constructed in parallel with the Streets Ahead programme.

In the last financial year, Amey worked in around 20 zones. Each zone was inspected by Officers to ensure that works on the request list complimented the work that Amey were already planning. If so, they were prioritised for construction. Although the numbers differed widely by zone, it is estimated that an average of six locations from the small scheme request list were implemented in each zone. This

equated to around 120 locations in the year.

In terms of 'enhancement' schemes, the following schemes were delivered by the end of the last financial year: zebra crossing on Furniss Avenue, pedestrian refuge on Gower Street, pedestrian improvements on Johnson Street and Manchester Road, new pedestrian crossing facility at the Gleadless Road/Daresbury Road traffic lights, narrowing of Stumperlowe Lane at Fulwood Road, bus stop improvements in Wybourn and school entrance improvements at Jepson Road and Newman Road.

Questions of Councillor Roger Davison to Councillor Mary Lea (Cabinet Member for Culture, Parks and Leisure)

1. What activities and services previously provided by Activity Sheffield will still be available now and after the next financial year?

The remaining small team (2.5 Officers) will focus in the main on facilitating city partnerships such as Move More, working with Sport England and governing bodies, advising on key community sports projects, commissioning of services, management of leases and funding agreements and drawing down funding to the city and local communities. The team was reduced in previous years and has not been directly involved in delivering activities.
2. What savings have been made by the closure of Activity Sheffield?

No savings have been made. The £400,000 Public Health funding will be redirected into the Parks Service. This will fund new capital projects in parks in areas of highest health inequalities.
3. What has happened to any capital equipment (such as the blow up 5 a side pitch) that was under the control of Activity Sheffield?

The team is currently reviewing options. This will include selling, transferring to partners or loaning. We will ensure this is done in an equitable way with a focus on best value for the Council and support to community organisations where possible.
4. Are there any outdoor events planned for this summer in the centre of Sheffield?

We are running a comprehensive calendar of events in the city centre this year.
