AMENDMENTS TO THE LEADER'S SCHEME OF DELEGATION OF EXECUTIVE FUNCTIONS

1. Introduction

1.1 This report provides details of amendments made by the Leader of the Council to her Scheme of Delegation of Executive Functions, effective from 8th and 20th February 2019.

2. Background

- 2.1 Section 7.06 of Article 7 (The Executive) of Part 2 of the Council's Constitution states that the Leader will "maintain a scheme of delegation setting out responsibilities for executive functions as between the Cabinet as a whole, individual Executive Members, Committees of the Cabinet (the membership of which can only include Cabinet Members), Area Committees, Officers and joint arrangements or otherwise as permitted by law". It also states that "the Leader will notify the Monitoring Officer of any changes to the Leader's Scheme. These changes will come into effect on receipt of the notification by the Monitoring Officer (or his/her deputy) or at such later time as the Leader may specify at the time of notification".
- 2.2 Section 1.2 of Part 4(e) (Executive Procedure Rules) of the Constitution states that "Where the Leader amends the Scheme of Delegation of Executive Functions in accordance with Article 7, the Leader will inform the Monitoring Officer and the Monitoring Officer will as soon as practicable present a report to an Ordinary Meeting of the Council setting out the changes made by the Leader".

3. Amendments Made To The Scheme of Delegation of Executive Functions

- 3.1 On 8th February 2019, the Leader of the Council gave notice to the Council's Monitoring Officer of amendments which she had made to Schedules 1, 2, 3, 6 and 9 of her Scheme of Delegation of Executive Functions, and to replace Appendices A to J with a new Appendix A setting out the list of Cabinet Portfolio areas of responsibility. The reasons for the amendments were to reflect the current titles of the Portfolios of the Cabinet Members; to reflect changes to officer job titles and delegations; and to update the delegations to the Director of Legal and Governance in relation to measures to counter anti-social behaviour.
- 3.2 A copy of the Leader's Notice of Amendment is attached to this report (Appendix A), and all Councillors were informed of its content, by email on 14th February.
- 3.3 On 20th February 2019, the Leader gave notice to the Monitoring Officer of amendments which she had made to Schedules 1, 3, 4 and 9, and to Appendix A, of her Scheme of Delegation, to reflect further changes to the Cabinet Portfolios and areas of responsibility, resulting from the Leader's removal of the Transport and Development Portfolio from the Scheme.

- 3.4 A copy of the Leader's Notice of Amendment is attached to this report (Appendix B). Appendix C details how the responsibilities of the former Transport and Development Portfolio have been re-allocated between the Leader's, Business and Investment, and Environment and Transport (new Portfolio title) Portfolios. All Councillors were informed of this content, by email on 26th February.
- 3.5 The Scheme of Delegation, incorporating both sets of amendments, has been published on the Council's website <u>Leader's Scheme of Delegation February</u> 2019.

'The Chief Legal Officer is authorised to discharge any Council function relating to measures to counter anti-social behaviour including giving any consents or confirmations on behalf of the Council, provided that, without affecting the generality of paragraph 4.1 above, this authorisation shall not extend to a Council function relating to anti-social behaviour relating to a particular tenancy.'

• 4.3. The addition of the words 'or required by law' at the end of the paragraph to read:-

'For the avoidance of doubt, paragraph 4.2 above does not restrict the ability of any Officer, Councillor or decision-making body to discharge any Council function relating to anti-social behaviour where this is permitted by the other provisions of this Scheme or required by law.'

- 6.2. Job title of the Director of Human Resources replaced by the Director of Human Resources and Customer Services.

- 10.1. Job title of the Director of Creative Sheffield replaced by the Director of City Growth and title of Cabinet Member for Business, Skills and Development replaced by the Cabinet Member for Business and Investment.
- 11.2. Job title of the Director of Creative Sheffield replaced by the Director of City Growth and the job title of the Head of Transport, Traffic and Parking Services replaced by the Head of Strategic Transport and Infrastructure.
- 11.3. Job title of the Director of Development Services replaced by the Director of Culture and Environment.
