

### 705 Abbeydale Road, Sheffield, S7 2BE

### 1.0 PURPOSE OF REPORT

1.1 To consider an application for the grant of a premises licence made under section 17 of the Licensing Act 2003.

### 2.0 THE APPLICATION

- 2.1 The applicant is Ranet Retail Limited.






