

1.0 PURPOSE OF REPORT

1.1 To consider a premises licence application made under the Licensing Act 2003.

- 3.2 As the representations have not been resolved, the matter is referred to the Licensing Committee.
- 3.3 The applicant and representatives from 3.1 have been invited to attend the hearing. Copies of the front page of the notices are attached to this report labelled Appendix 'F'.

4.0 FINANCIAL IMPLICATIONS

4.1 There are no specific financial implications arising from this application. However, additional costs may be incurred should the matter go to appeal. In such an eventuality it may not be possible to recover all these costs. The impact of these additional costs (if any) will be kept under review and may be subject of a further report during the year.

5.0 THE LEGAL POSITION

5.1 The Licensing Act 2003 at section 4 (1) requires the Licensing Authority to carry out its functions with a view to promoting the Licensing Objectives which section 4(2) sets out as: -



- a) the prevention of crime and disorder,
- b) public safety,
- c) the prevention of public nuisance,
- d) the protection of children from harm.
- 5.2 Section 4(3) of the Licensing Act also requires the Licensing Authority to have regard to the published statement of Licensing Policy and any guidance issued by the Secretary of State under section 182.

6.0 HEARINGS REGULATIONS

- 6.1 Regulations governing hearings under the Licensing Act 2003 have been made by the Secretary of State.
- 6.2 The Licensing Authority has provided all parties with the information required in the Regulations to the 2003 Act as set out at Appendix 'G'.
- 6.3 Attached at Appendix 'G' is the following:
 - a) a copy of the Notice of Hearing;
 - b) the rights of a party provided in Regulations 15 and 16;
 - c) the consequences if a party does not attend or is not represented at the hearing
 - d) the procedure to be followed at the hearing.

7.0 APPEALS

7.1 The Licensing Act 2003 section 181 and Schedule 5 makes provision for appeals to be made by the applicant and those making representations against decisions of the Licensing Authority, to the Magistrates' Court.

8.0 RECOMMENDATIONS

8.1 That members carefully consider the representations made and take such steps, as the Committee consider necessary for the promotion of the Licensing Objectives.

9.0 OPTIONS OPEN TO THE COMMITTEE

Further to your below email I have considered your proposals and although we are now satisfied with the suggested opening times the basis of our objection has still not been addressed.

Our main concerns centre around the premises operating as a skate park alongside the sale of alcohol. Upon meeting Mr O'Donnell there appeared very little in place to prevent the sale of alcohol to those utilising the skating facility which causes great concern for the potential of individuals conducting sporting events whilst under the influence of alcohol. Mr O'Donnell made the suggestion that sporting equipment would be confiscated when a customer purchased a drink however Mr O'Donnell was unable to confirm how this could be successfully enforced and how individuals would be successfully prevented from re-entering the sporting facility.

Mr O'Donnell advised his target market would primarily be those under the age of 18 therefore the sale of alcohol alongside the skating facility appeared at conflict with the age of the clientele. Although we can appreciate there may be customers over the age of 18 attending there appeared little in place to prevent under age sales or proxy sales.

I must advise I am not in a position to withdraw my representation at this stage and attach the conditions we would require in order for our objection to be withdrawn.

- The supply of alcohol will only be authorised during private pre-booked events which are closed to the public. There will be no alcohol sales during any time when the premises are allowing customers to use the indoor skating facilities.
- A CCTV system to the specification of South Yorkshire Police will be fitted, maintained and in
 use at all times whilst the premises are open (in line with specification July 2011). The
 CCTV images will be stored for 28 days and police and authorised officers of the council

I am writing on behalf of the Sheffield Safeguarding Children Board to make a Representation in relation to the above application. The reason for the Representation is stated below and I would ask the Licensing Authority to consider that, if the application is granted, the proposed conditions should be attached to the premises licence for the Protection of Children from Harm, under The Licensing Act 2003.

I note from the application and from discussion with the applicant at a meeting on 12th June 2012, that if a licence is granted, the premises would operate primarily as an indoor entertainment venue for children and young people, providing skateboard facilities and refreshments. The applicant has confirmed that the day to day business at the premises would attract unaccompanied children and young people as well as adults. Having discussed the proposed style and character of the venue with the applicant and potential risks of the proposed operation, it was verbally agreed by the applicant on 12.6.12 that the provision of alcohol would be withdrawn from the application. However this has not yet been confirmed in writing.

In light of the style of the premises which is designed primarily to facilitate sporting facilities for unaccompanied children and young people, I am concerned that if the licence is granted, alcohol will be on sale daily from 11am until 6am the next day. This presents a risk of unaccompanied children and young people being exposed to disinhibited alcohol related behaviour whilst engaging in sports activities. There is also a risk of underage drinking and proxy purchase as the design of the building does not provide for supervision of the consumption of alcohol from the bar, there is no restricted drinking area and the measures offered in the operating schedule (Part P(e) state merely that "all persons are ID for age as a strict method of control (under 18/21)" which is unclear and inadequate in relation to what measures will be in place to prevent underage sales and proxy purchase.

In light of the above, I am writing to propose that the following licence conditions are considered by the Licensing Authority for the protection of children from harm, if the application is granted:

1. Alcohol must not be on sale or on deplay at times when persons under the age of 18 years are on the premises.

- 2. Regular and recorded security patrols must be made to ensure the environment remains safe and family friendly.
- 3. A suitable member of staff must be assigned to have lead responsibility for safeguarding systems in relation to children and young people. This person should act in compliance with the guidance and training provided by the Sheffield Safeguarding Children Board.

The above conditions would provide a clear and enforceable system to ensure that the premises provides a safe and appropriate environment for unaccompanied children and young people.

I am hopeful that in light of the verbal agreement made in relation to items (1) and (3) above this representation may be resolved without the need for a formal hearing. I will liase with the applicant and notify the Licensing Authority of any progress made. Please note that the Sheffield Safeguarding Children Board does provide guidance and training free of charge to support persons assigned with responsibility for safeguarding issues at the premises.

I am informed by our licensing service that, contrary to your indication in our meeting of Tuesday this week, you have not as yet withdrawn your application for a premises licence at the above location. I therefore feel it appropriate to remind you of the objection I have already notified you of, as outlined below. This objection is made on the basis of my concerns that the activities and timings you propose are likely to give rise to public nuisance due to noise. Please note that this email is copied to the licensing officer concerned.

You have requested a licence which allows licensable activities from 11:00 to 06:00 including, inter alia; supply of alcohol; live and recorded music; dancing; late night refreshment. In my opinion this allows for the use of the premises as a nightclub style venue. This is contrary to the stated intention of the skatepark as the primary use. This opinion is supported by the fact that when applying for planning permission for the development of these premises, the application was initially for use as a nightclub, and was only revised to a skatepark use when the planning service advised nightclub use would be refused.

The location of these premises is in an area which is currently the subject of concern, both to Environmental Protection, the police and the Local Planning Authority. This is due to noise issues associated with various nearby licensed premises, premises issued with Temporary Events Notices and unlicensed 'rave' events. There are a number of active complaints due to noise from amplified live and recorded music played at night in nearby buildings (including the adjoining industrial premises which are likewise not designed to attenuate noise form regulated entertainment). The area has a number of nearby residential properties which, whilst not immediate neighbours, have suffered nuisance due to noise from such activities.

The fabric and structure of this building, in particular the roof structure, are unsuitable for any use involving loud amplified music. You have stated in section P. (d.) of your application (steps to prevent public nuisance) that there is a noise limiter in use. It was clear at the point of our meeting that this is not the case as yet. Regardless, I am of the opinion that with the current building structure, use of a limiter would not be sufficient in itself, as the setting would need to be so low as to render the proposed use impracticable.

I am also aware that the current planning conditions in place for these premises (covering the permitted use of 'skatepark with ancillary licensed bar' prohibit this use after 23:30 hours on all

days. This restriction was imposed primarily because of concerns regarding the potential for detriment to the amenity of the area in terms of noise disturbance.

For me to withdraw this objection, I require that the following conditions are agreed and formally included in your application proposal:

- 1. Prior to the commencement of any licensable activities on the premises, a scheme of substantive structural improvements to the fabric of the building designed to mitigate noise breakout to agreed levels must be agreed in writing with Sheffield City Council Environmental Protection Service and implemented in full. The agreed scheme of works shall be thereafter retained.
- 2. No amplified sound shall be played in the premises except through an in-house amplified sound system fitted with a sound limiter and a cut off device connected to all emergency fire doors, the settings of which shall have received the prior written approval of the Environmental Protection Service.
- 3. All ventilation outlets, which serve the licensed area, are to be acoustically baffled and there after retained.
- 4. All doors and windows shall be closed, save for access and egress, whenever regulated entertainment is present in the premises.
- 5. The premises licence holder shall prominently display notices on all exits reminding patrons to leave the premises in a quite and orderly fashion and to respect the local neighbours' needs.
- 6. The premises will not open in excess of their permitted hours as limited by the Local Planning Authority at any time.

Regarding the hypothetical scenario set out below; I can only give an opinion on these proposals in relation to the core objective of the prevention of public nuisance. I am happy to give my opinion, but in the absence of any clear instruction to vary the licence application, I am not in a position to withdraw my representation at this stage.

In principle, I have no objection to music at background level only. As you will be aware, background level music is not a licensable activity. I would also be reassured if the business were restricted by licence condition to the hours currently specified on the planning consent for the premises use as a skate-park, which are 0800 – 2330 hours on any day.

I would take an interest if I were consulted on any TEN application for this premises, given the history. I would not necessarily object outright, but I would want to reassure myself that adequate measures were in place to reduce potential for noise nuisance. I am unclear as to how noise from such events would be controlled, given the proposal for the in-house system to be restricted. As I have already advised Mr O'Donnell, any nuisance complaints received as a result of any TEN granted would reinforce my current concerns if I am required to comment on a subsequent application to vary an existing licence.

I must stress that these opinions are based on the scenario that you have outlined below, and do not prejudice any representation I may make regarding the forthcoming committee hearing for the above premises. I have been asked by Paul O'Donnell to assist him with regards to the problems he is encountering in respect of his recent licencing application for The Industry Indoor Skate Park at Unit 9-11 Smithfield, Shalesmoor, Sheffield.

I have looked at his submission and the planning approval and I have also seen the various responses from the authorities concerned. It is obvious that the application that has been submitted has far exceeded what was originally intended and approved. Consequently I discussed the matter with Paul and he explained that his intention was only to give the business more options and not to open a 'nightclub' style venue that could create the problems that have been highlighted in the various responses.

I have advised him that he must restrict his activities to those already agreed and that if there are occasions when he wants to have a 'special event', he will need to deal with that situation as an event on its own and obtain the necessary permissions/licences at the time. My company ARI Environmental Services is an Environmental Health consultancy dealing with many planning and licencing issues and we have agreed to act as consultants to The Industry to ensure that it can comply with all the requirements in terms of nuisance and public safety. Within this application and amongst other licensable activities, you have applied for the provision of alcohol, the provision of facilities for dancing and live entertainment. The hours applied for are until 6am. The application as it stands would allow the premises to operate in a nightclub style.

After liaising with colleagues in the planning department, it was brought to our attention that the original planning application submitted was primarily for a nightclub with skateboarding facilities. You will be aware that there are restrictions from planning regarding the usage of this building.

From a public safety aspect, the potential combination of alcohol consumption and participation in skateboarding and BMX activities would have a detrimental effect on safety which gives me serious concerns regarding for both the user of the facilities, staff and spectators alike.

The current British Standard for roller sports, BS EN 14974:2006 +A1:2010 was also brought to your attention during the meeting. The requirement for a Post Installation Inspection was discussed to ensure that the Skate Park meets the requirements of the above British Standard before it is used by the public.

The plan (Drawing 11-11, revision D) accompanying this application states that the occupancy shall be 360 persons. I have concerns regarding this figure and the practicality

of such occupancy. Furthermore, facilities shown on the plan would only accommodate 150 people under the current British Standard for toilet facilities-BS 6465-2006+A1:2009.

Furthermore, the above plan does not clarify which areas are to be licensed, so it is assumed that as it stands at the moment, the entire site is being applied for.

I also briefly discussed the following points;

- Control of legionella with respect to the showers to be installed at the premises
- Suitability of floor finishes
- Electrical safety
- Management of emergencies

During the site meeting you were given various options by the Responsible Authorities, and you informed us that you would seek to withdraw this application due to concerns raised. You stated that you would look to submit Temporary Event Notices (TEN's) for corporate events.

Therefore, at this stage I have no option but to strongly object to the granting of the licence on public safety grounds. If you require any further information, please do not he sitate to contact me on the telephone number shown.



Right of attendance, assistance and representation

Subject to regulations 14(2) and 25, a party may attend the hearing and may be 15. assisted or represented by any person whether or not that person is legally qualified.

Representations and supporting information

At the hearing a party shall be entitled to -16.

- (a) in response to a point upon which the authority has given notice to a party that it will want clarification under regulation 7(1)(d), give further information in support of their application, representations or notice (as applicable),
- (b) if given permission by the authority, question any other party; and

(c) address the authority

Failure of parties to attend the hearing

20. - (1) If a party has informed the authority that he does not intend to attend or be represented at a hearing, the hearing may proceed in his absence.

(2) If a party who has not so indicated fails to attend or be represented at a hearing the

(a) where it considers it to be necessary in the public interest, adjourn the hearing to a specified date, or
