#### 1.0 PURPOSE OF REPORT

1.1 To consider the renewal of a Static Street Trading consent outside Botanical Gardens on Clarkehouse Road, following the implementation of a new Traffic Regulation Order.

#### 2.0 INTRODUCTION

- 2.1 The Council as a Licensing Authority have power under the provision of the 1982 Act to regulate Street Trading in the City.
- 2.2 A Street Trading Consent is required to trade on any Street (which includes roads, footways, forecourts, or other areas to which the public have access) within the Sheffield City Boundary.
- 2.3 The Licensing Committee at its meeting of 29<sup>th</sup> January 2002 passed the following resolution:
  - 1. That under the provisions of schedule 4 of the Local Government (Miscellaneous Provisions) Act 1982:
    - (a) all streets (which includes roads, footways, forecourts or other areas to which the public have access) within the Sheffield City boundary, shall be designated consent streets and;
    - (b) such street trading designation shall take effect as from the 1<sup>st</sup> April 2002; and
    - (c) all previous designations in relation to street trading will be rescinded as a result of the designation set out above.
  - 2. The effect of this resolution is that from 1<sup>st</sup> April 2002, it will be an offence to engage in street trading in any street or any other place identified in the above resolution without being authorised to do so by consent from the City Council.
- 2.4 A Local Authority may attach conditions to a Street Trading Consent. The conditions may include conditions to prevent obstruction of the street and danger to persons using the street or nuisance or annoyance.

- 2.5 A Street Trading Consent may only be granted for a maximum period of twelve months.
- 2.6 There is no appeal procedure against the refusal or revocation of any consent. An applicant may, however apply for judicial review of the Council's decision.

#### 3.0 BACKGROUND

- 3.1 The Consent holders, Mr Cuneo & Ms Saqladi, hold a Static Street Trading Consent to operate an Ice Cream Van directly outside the Botanical Gardens gates on Clarkehouse Road, and have done so for a number of years. This consent expires on the 30<sup>th</sup> of November each year. Mr Cuneo & Ms Saqladi have submitted their renewal application for this site, a copy of which can be found at Appendix 'A'.
- 3.2 Earlier this year, the Licensing Service was made aware of the introduction of a new Traffic Regulation Order (TRO) at the consent site (outside Botanical Gardens on Clarkehouse Road) by Sheffield City Council's Traffic Regulation Department.
- 3.3 In support of this new TRO, Parking Services confirmed that they would actively enforce the parking restrictions at this location, which led to the traders receiving a Penalty Charge Notice.
- 3.4 A Licensing Sub-Committee hearing was held on the 14<sup>th</sup> October 2019 to review this consent site and consider the revocation of the consent as it contravened the Street Trading Condition which states:
  - "The consent holder shall at all times obey all road traffic regulations in force in the consent area"
  - A copy of this hearing report detailing the TRO information can be found at Appendix 'B'
- 3.5 The outcome of this hearing was to defer the decision until a meeting could be held between the Traders and the necessary Council departments to see if there was any method of compromise or remedy, with revocation being the last resort given the extended number of years that the traders had been located at the site, and the Council's vision to support and facilitate local business to trade within the city.
- 3.6 Several meetings have been held between the relevant Council departments and the Traders, and it has been recommended by the Head of Strategic Transport, Sustainability and Infrastructure that the site is not viable as a trading site. The evidence to support this recommendation has been collated by the Head of Strategic Transport and a Road Safety Auditor, and can be found at Appendix 'C'.

#### 4.0 REASONS FOR REFFERAL

4.1 The Licensing Authority has no power to override a TRO, and the TRO which is in place at this site forbids any stopping or loading at any time.

- 4.2 PLEASE NOTE: The Street Traders have submitted a Judicial Review of the implementation of the TRO process in October 2019 which has not yet been determined. It is required to be noted, that if the TRO is overturned and the Bus Stand is removed at this site, the restrictions which were in place prior to the TRO coming in to force will be applicable, which were double yellow lines that do not allow stopping at any time.
- 4.3 The applicants and representatives from Strategic Transport, Sustainability and Infrastructure and Parking Services have been invited to attend the Licensing Sub-Committee hearing. Copies of the hearing notices and hearing procedure are attached at Appendix 'D'.

#### 5.0 FINANCIAL IMPLICATIONS

- 5.1 The Street Trading Policy states that fees will be set and reviewed annually on a full cost recovery basis. The level of fee takes into account the location, duration of consent, the trading hours and articles to be sold as well as the enforcement of terms and conditions.
- 5.2 Fees for static consents are determined at the grant of the application therefore there are no financial implications arising from this report.
- 5.3 Where a consent is surrendered or revoked, the council shall remit or refund, as they consider appropriate, the whole or a part of any fee paid for the grant or renewal of the consent.

#### 6.0 RECOMMENDATIONS

6.1 That Members carefully consider all the relevant information available, any representations submitted and the Sheffield City Council Street Trading policy.

### GUIDANCE FOR A STATIC STREET TRADING APPLICATION NOTES FOR APPLICANTS

The purpose of the Street Trading process is to allow the selling or exposing or offering for sale of any article (including a living thing) in a street, under the Local Government (Miscellaneous Provisions Act 1982

The Council passed a resolution under Schedule 4 of the above Act designating all streets (which includes roads, footway, forecourts, or other areas to which the public have access) within the Sheffield City Boundary as consent streets.

This designation took effect from the 1<sup>st</sup> April 2002. The effect of the above resolution is that from the aforementioned date, it is an offence to engage in street trading in any street or other place identified in the above resolution without being authorised to do so by consent from the City Council.

If you wish to street trade in Sheffield, you must apply to the Licensing Authority. Please ensure you fully read our Street Trading Policy before making an application to us. This can be viewed at <a href="https://www.sheffield.gov.uk/licensing">www.sheffield.gov.uk/licensing</a>.

Any street trading consent granted under the Local Government (Miscellaneous Provisions) Act 1982 will generally remain in force for one year or for such shorter period as the licensing authority thinks fit.

Static street trading is trading in one site for **more** than 20 minutes. If a trader wishes to move around in various parts of the city for a period of less than 20 minutes at each site they are required to apply for the relevant mobile street trading consent.

Static street trading is where a pitch is identified and a Consent holder trades only from that pitch within the terms of the Consent issued.

These pitches are usually very specific and traders are given consent based on the **detailed** plan submitted on application.

It would be up to the trader to locate a pitch and make an appropriate application with the Authority.

Applicants **must contact the Highways and Planning services** prior to submitting your application to discuss any issues they may have and whether any other permissions are required.

It is not possible for traders to move pitch, even just a short distance, without the prior consent of the Licensing Service.

All static street trading consents expire on the 30<sup>th</sup> November.

#### 1. Eligibility Criteria

An applicant:

Must be at least 17 years old

#### 2. Fee

The Quarterley or Annual Fee to be paid on application (The Licensing Service no longer accepts cash or cheque payments)

#### 3. Application

All questions on the application form must be answered unless otherwise stated. If relevant questions are not answered, the application will be deemed incomplete and returned to the applicant. Application forms are available from <a href="https://www.sheffield.gov.uk/licensing">www.sheffield.gov.uk/licensing</a>

To apply for the grant of a Static Street Trading Consent an applicant must produce to the Council:-

- a) The remaining quarterly fee or full annual fee.
- b) A certificate of insurance in respect of the vehicle or tow vehicle you propose to use.
- c) An appropriate vehicle test certificate.
- d) A certificate of public liability insurance (the level of cover shall be a minimum of £2,000,000).
- e) Written confirmation that the vehicle meets the Council's food safety standards.
- f) Waste management contract.
- g) Declare that you have registered as a food business.

#### 4. Traffic Regulation Orders

You will need to be aware of any parking restrictions (yellow lines) and other traffic restrictions on the highway when deciding where to site your vehicle.

If you think there is a traffic regulation order that might affect your consent, you must contact the traffic regulations section on (0114) 273 6178 or email Traffic\_Regs@sheffield.gov.uk before you submit your application.

#### 6. Objections

Any person objecting to an application for a consent shall give notice of their objection in writing not later than 28 days after the date of the application.

In any cases where an objection is received the application will be referred to Members of the Licensing Committee for their consideration. The applicant and objectors will be notified of the hearing and will be invited to attend.

#### 7. Grant of a Licence

The Council may grant to any applicant a consent to trade in the terms and conditions as specified by the Council.

A consent will remain in force for one year, or such shorter period specified on the consent, unless previously cancelled or revoked.

All static consents expire on the 30<sup>th</sup> November.

#### 8. Offences

It is an offence for any person to engage in street trading in a consent street without being authorised to do so except under and in accordance with the terms and conditions of a consent granted by the appropriate Authority.



The maximum penalty on summary conviction is £1000 for each offence (each individual sale would constitute a separate offence).

Any person who, in connection with an application for the grant or renewal of a consent, makes a false statement which he knows to be false in any material respect or which he does not believe to be true shall be guilty of an offence.

#### 9. Other Legislation to be Aware of

#### **Food Establishments**

Food establishments must be registered with Environmental Health (contact (0114) 273 5774 / 273 4415 or email: healthprotection@sheffield.gov.uk).

It is a criminal offence to operate a food business without registering.

There is no charge for registering with Environmental Health.

#### **Trade Waste Disposal**

You have a legal responsibility under the Environmental Protection Act 1990 and other related legislation to safely contain and legally dispose of any waste produced from your business. If you don't, you may be prosecuted.

#### Identification of Consent Holders and Assistants

Consent holders must ensure that any person who is working on the site has obtained the relevant authorisation in the form of an identification badge from the Licensing Service.

Application forms for assistant identification badges can be collected from the Licensing Service.

Along with the form, the consent holder and any assistants must submit two (recent and identical) passport size photographs signed and dated on the reverse as a true likeness. These will be used to issue an identification badge.

Assistant badges will be at a cost of £32 each.

Lost or replacement badges will be at a cost of £22 for consent holders and assistants.

The identification badge must be worn by the person/s working at all times.

Consent holders must ensure that the Licensing Service are immediately informed of any new assistants that are employed to work. Assistants may not commence work until being issued with the appropriate identification badge.

The consent holder must not allow anybody under the age of 17 to work on the pitch.

# CITY WIDE STREET TRADING QUALITY SPECIFICATION (This specification does not include the city centre)

#### **UNIT DESIGN**

- Good display is an important part of the selling process and top quality presentation encourages purchase and benefits the retailers' reputation.
- It is in the best interest of traders to produce a high quality design both internally and externally in their unit.
- The function of the unit is to identify the trader and add vitality and colour to the immediate area, and reflect the quality, cleanliness in their operation. The unit must contribute to the appearance of the area for good or bad, so design matters to everyone who uses the street, as well as the operator.
- Stalls must enhance the visual appearance of the street rather than detract from it and be constructed in a suitable style and of appropriate materials.

Examples of acceptable designs include:

- Modern, simple, functional stalls with umbrellas, canopies or striped awnings.
- o Traditional or 'period' type handcarts, barrows or tricycles.
- The stall design should be fully accessible for all customers.
- The outside of the unit will be limited to the name of the stall, the type of product sold and a simple price list. Ad hoc pictures and advertiser's slogans should be avoided, as should untidy handwritten signs.
- Advertisements on stalls will not be permitted except by permission of the Council in writing and subject to further conditions. The Council shall be the sole judge of what is an acceptable advertisement.
- Sign writing and scrollwork must be finished to a standard acceptable to the City Council.
- The unit must be visually acceptable to the City Council.
- The general design of the unit must meet the requirements of the Council for the location and proposed hours or days of trading. A photograph of the actual unit or proposed model must be submitted on application.
- Bright colours and a sense of fun are encouraged.
- Pitched and curved roofs are encouraged.
- Canopies must be maintained and cleaned.
- No expenditure on units or equipment should be made until the Council has granted consent and the unit design has been approved.
- The internal layout of the unit must be clean and to a high standard.
- Non-motorised vehicles (ie carts/barrows) are encouraged in pedestrian areas. For example shopping areas like Woodseats, Hillsborough, etc.

- Motorised vehicles should not be of an age of 5 years or over.
- Mobile trading vans must have a side hatch to serve customers.
- The unit / vehicle must be clearly identifiable as a trader.

#### **Environmental Health considerations of the unit design:**

#### For Enclosed Food units:

- The internal arrangements must be such that:
  - o There is suitable and sufficient hand washing facilities with hot water;
  - The work surfaces are impervious to water and readily cleansable;
  - There is sufficient compliant temperature controlled food storage facilities appropriate to the business;
  - The gas and electrical installations are certificated and deemed to be safe by a competent and suitably qualified engineer; any gas store cupboard should be outside of the food area;
- The external arrangements must be that the mobile is sufficiently weather and pest proof so as to not risk the contamination of the food.

#### For Market-Stall or Street-Barrow type food units:

- The stall must be covered to prevent the risk of matter falling on to the food;
- The work surfaces likely to be in contact with the food must be impervious to water and readily cleansable;
- Any intrinsic storage food area must be able to be secured against the intrusion by pests;
- If temperature controlled food is to be stored on the mobile, the storage facility shall be capable of maintaining the food in a legally compliant manner;
- That there are adequate hand washing facilities.

#### Food Hygiene record (for all food stalls) - all food regulations have been adhered to:

- The applicant will need to demonstrate that:
  - they have registered with their home Local Authority;
  - all food handlers have received adequate food safety training appropriate to their job role;



- the food business has a legally compliant Food Safety Management System (e.g. Safer Food, Better Business);
- o if there is a history of non-compliance, it has been addressed and accepted by the Food Safety Enforcing Officer, or that the food business is in the process of addressing the issues and the Food Safety Officer does not consider the defect too severe so as to prohibit the food business from trading; and
- their business has a food hygiene rating score of at least 3.

#### **DRESS**

- Trader and their assistants must be identifiable (i.e wear a uniform).
- The style of dress worn by stall operators should be chosen to complement the style and period of the unit.
- Over clothing must always be smart and clean. Operators of food stalls should ensure that sufficient changes of clothes are provided so as to enable personnel to always wear over clothing, which is clean.
- Personal cleanliness is also important and persons employed at food stalls are required to have good personal hygiene.

#### **GENERAL**

- Vehicles used to tow trailers must be parked legally at all times.
- The Council will reserve the right to not renew any consent where it considers the product/s offered by the operator are not in keeping with the requirements of the site.



#### 1.0 PURPOSE OF REPORT

1.1 To consider revoking a Static Street Trading consent outside Botanical Gardens on Clarkehouse Road, following the implementation of a new Traffic Regulation Order by the Traffic Regulation Department at the consent site.

#### 2.0 INTRODUCTION

- 2.1 The Council as a Licensing Authority have power under the provision of the 1982 Act to regulate Street Trading in the City.
- 2.2 A Street Trading Consent is required to trade on any Street (which includes roads, footways, forecourts, or other areas to which the public have access) within the Sheffield City Boundary.
- 2.3 The Licensing Committee at its meeting of 29<sup>th</sup> January 2002 passed the following resolution:
  - 1. That under the provisions of schedule 4 of the Local Government (Miscellaneous Provisions) Act 1982:
    - (a) all streets (which includes roads, footways, forecourts or other areas to which the public have access) within the Sheffield City boundary, shall be designated consent streets and;
    - (b) such street trading designation shall take effect as from the 1<sup>st</sup> April 2002; and
    - (c) all previous designations in relation to street trading will be rescinded as a result of the designation set out above.
  - 2. The effect of this resolution is that from 1<sup>st</sup> April 2002, it will be an offence to engage in street trading in any street or any other place identified in the above resolution without being authorised to do so by consent from the City Council.

- 2.4 A Local Authority may attach conditions to a Street Trading Consent. The conditions may include conditions to prevent obstruction of the street and danger to persons using the street or nuisance or annoyance.
- 2.5 A Street Trading Consent may only be granted for a maximum period of **twe**lve months.
- 2.6 There is no appeal procedure against the refusal or revocation of any consent. An applicant may, however apply for judicial review of the Council's decision.

#### 3.0 BACKGROUND

- 3.1 The consent holders Mr Cuneo and Ms Saqladi hold a Static Street Trading Consent to operate an Ice Cream van directly outside the Botanical Gardens gates on Clarkehouse Road. A copy of this consent can be found at Appendix 'A'.
- 3.2 The Licensing Service has been made aware of the introduction of a new Traffic Regulation Order (TRO) at the consent site (outside Botanical Gardens on Clarkehouse Road) by Sheffield City Council's Traffic Regulation Department.
- 3.3 The first TRO came in to force on the 9th May 2019 with the following restrictions "No Waiting at Any Time" a Bus Stand has also been placed at the consent site (which does not require an Order). The 'Bus Stand' signage was not erected at the time to make this restriction to not park enforceable. Mr Cuneo and Ms Saqladi have therefore continued to trade up until recent weeks.
- 3.4 As of the week commencing 9<sup>th</sup> September 2019, the Licensing Service has been advised from Parking Services that the signs and lines are now in accordance with the 'Traffic Signs Regulations and General Directions 2002' instrument and will therefore be enforcing the parking restrictions in place. Details of this TRO can be found at Appendix 'B'.
- 3.5 Mr Cuneo and Ms Saqladi have already received a Penalty Charge Notice for being in their trading position which contravenes the TRO, and it has been confirmed by the head of Parking Services that the parking restrictions are now being actively enforced, putting the traders at risk of further fines if they continue to trade there.
- 3.6 The Licensing Service has received further notification from the Traffic Regulations Department that a second, revised TRO is to be in force as of 7<sup>th</sup> October 2019, which stipulates "No waiting At Any Time Midnight to 2.30pm and 4pm to Midnight (to allow active loading/unloading for businesses in the Botanical Gardens and disabled drivers with timed blue badges to use as these are exempt from the restriction) and the Bus Stand will operate 2.30pm-4pm. These restrictions therefore stipulate that there would not be any time throughout the day which would allow legal parking at this site for the traders. Details of this TRO can also be found at Appendix 'B'.

#### 4.0 REASONS FOR REFFERAL

4.1 Sheffield City Council's Standard Street Trading condition 43 states:

"The consent holder shall at all times obey all road traffic regulations in force in the consent area".

- 4.2 The Licensing Authority has no power to override a Traffic Regulation Order.
- 4.3 The new TRO which has been implemented at this site forbids any stopping or loading at any time, therefore making this consent site unviable to continue trading against the traffic regulations and public safety. A full copy of the Standard Street Trading Conditions can be found at Appendix 'C'.
- 4.4 The Licensing Service have met with the consent holders to assist in finding a possible alternative location, both Mr Cuneo and Ms Saqladi feel there is no other viable location and have requested their consent to be referred to the Licensing Committee.
- 4.5 Under the Street Trading legislation, there is no process to review a street trading consent; Mr Cuneo and Ms Saqladi do not wish to find an alternative location which leaves the Council to look at revoking the current consent in line with our policy, conditions and public safety issues following the introduction of the TRO. Members are to refer to section 2.8 of the street trading policy which refers to factors which should be considered when revoking a consent.
- 4.6 Members should also note, revocation of a consent can only be determined by the Licensing Sub-Committee, please see Appendix 8 of the street trading policy.
- 4.7 Members should consider all the information provided by the applicant in person at the hearing, as well as all details provided within this report.
- 4.8 Mr Cuneo and Ms Saqladi have been invited to attend the Licensing Committee hearing. Copies of the invites are attached at Appendix 'D'.
- 4.9 A copy of the hearing procedure is also attached at Appendix 'D'.

#### 5.0 FINANCIAL IMPLICATIONS

- 5.1 The Street Trading Policy states that fees will be set and reviewed annually on a full cost recovery basis. The level of fee takes into account the location, duration of consent, the trading hours and articles to be sold as well as the enforcement of terms and conditions.
- Fees for static consents are determined at the grant of the application therefore there are no financial implications arising from this report.

5.3 Where a consent is surrendered or revoked, the council shall remit or refund, as they consider appropriate, the whole or a part of any fee paid for the grant or renewal of the consent.

#### 6.0 RECOMMENDATIONS

6.1 That Members consider all the relevant information available, any representations that may be made and our policy.

#### 7.0 OPTIONS OPEN TO THE COMMITTEE

- 7.1 To defer the matter for further consideration.
- 7.2 To revoke the Static Street Trading Consent.

- c) In Schedule 1.01C thereto the items '276 Clarkehouse Road the south east side (i) (ii) and the north west side (i) (ii) (iii) (iv) (v)' and '430 Glossop Road the south east side (i)' were deleted.





Static Street Trading Conditions

#### LOCAL GOVERNMENT (MISCELLANEOUS PROVISIONS) ACT 1982

#### Standard Street Trading Consent Conditions

#### **AUTHORISATION**

- 1. The consent is only valid for the person named and is not transferable.
- 2. This consent enables the holder to trade in Sheffield from the area designated and between those times detailed in this consent only (if any).
- 3. The consent holder shall at all times have a copy of this consent available for inspection on request to any Police Officer or duly Authorised Officer of the Council.
- 4. A certificate will be issued along with the consent which must be clearly displayed on the vehicle or stall in a position that is clearly visible to customers and members of the public.
- 5. The consent holder shall only trade from the size and type of vehicle / stall / trailer specified in this consent.
- 6. The consent holder shall not use or permit anyone to use this consent to trade from anywhere other than the site detailed within this consent.
- 7. The consent holder shall ensure that a current price list of articles being sold is always prominently displayed on the vehicle or stall.
- 8. There shall be no alteration in the design / construction / appearance of the vehicle or stall without the written permission of the Council having been obtained.
- 9. There shall be no change in the range of articles sold without the written permission of the Council having been obtained.
- 10. The consent holder shall at all times have available for inspection an up to date and valid Certificate of Insurance (Vehicle and Public Liability) the level of Public Liability Cover shall be a minimum of £2,000,000.
- 11. The Council reserve the right, should the need arise from time to time, to direct that the consent holder shall not trade:
  - from the whole or any part of the site;
  - during certain times from the site;
  - and move to an alternative site for a small length of time;
     and the consent holder shall comply with that instruction.
- 12. In the event that the Council give a direction to cease trading from the whole of the site, the City Council shall deduct from the next fee instalment due, a sum proportional to the trading time lost. For the purposes of this calculation it shall be deemed that trading takes place on 7 days a week.

- 13. This consent will expire on the date given on the face of this consent, and the Council are under no obligation to renew such consent.
- 14. Consent holders shall notify the Council in writing of any permanent change of address as soon as it occurs. You must provide proof of your new address with your notification (i.e. utility bill, bank statement, etc.)
- 15. Consent holders shall ensure that disabled people and wheelchair users can be adequately served.

#### CONDUCT

- 16. Consent holders and any assistants employed by them shall ensure the public and Council officers are treated fairly and with courtesy. Traders shall ensure that their staff are competent, courteous and helpful.
- 17. Consent holders will not obstruct Authorised Officers of the Council or Police Officers at any time and will always be polite and courteous.

#### AREA

- 18. Any consent issued by the Licensing Service does not permit the holder to trade within "The City Centre Boundary" unless specifically stated.
- 19. Any consent issued for a street trader does not permit the holder to trade within 800 meter radius of any school in the Sheffield boundary unless authorised to do so.
- 20. Any consent issued for a mobile street trader does not permit the holder to trade within an 800 metre radius of the Sheffield Arena, Don Valley Stadium, Sheffield Wednesday and Sheffield United Stadiums on any event / match day (see plan for radius) for four hours previous, during and one hour after any event.

#### **ASSISTANTS**

- 21. The consent holder will only employ persons that are suitably qualified in food hygiene to assist him (unless trading in non food articles / goods).
- 22. The consent holder shall not permit any person under the age of 17 to engage in Street Trading.
- 23. The consent holder shall ensure that any person who is working on the vehicle, stall or designated area has obtained the relevant authorisation and is wearing the identity badge issued to them by the Council (this includes the consent holder and any other person who is assisting the consent holder in trading).
- 24. The consent holder shall ensure that any person who is working on the vehicle has a right to work in the UK and has made appropriate checks.

- 25. The consent holder shall ensure that the Council (Licensing Service) are informed immediately of any new assistants that are employed to work at the vehicle, stall or unit.
- 26. The consent holder shall supply a copy of these street trading conditions to every assistant employed by him and ensure they are fully aware of their responsibilities.

#### **FOOD HYGIENE**

- 27. The consent holder shall at all times observe proper food safety and hygiene standards and shall make appropriate use of any equipment provided for this purpose.
- 28. The applicant shall comply with all statutory requirements regarding food hygiene. The applicable legislation is:

### FOOD HYGIENE (ENGLAND) REGULATIONS 2006 FOOD REGULATIONS (EC) 852/ 2004.

- 29. In accordance with the food hygiene legislation the applicant must provide proof to the Council that the business/mobile food unit is currently registered with the food authority in which the stall, handcart, barrow or mobile food unit is currently stored.
- 30. The applicant together with all other persons employed in food handling activities are required to attend a food hygiene course commensurate with the food handling activities.
- 31. Food traders must meet a minimum of 3 in their food hygiene rating score.
- 32. The applicant must display their food hygiene rating score visibly to customers.

#### LEGAL PROVISIONS

33. Nothing contained in these conditions shall relieve or excuse the consent holder or their employees or agents from any legal duty or liability and at all times the consent holder shall comply with the relevant legislation in force.

#### **GENERAL**

- 34. The consent holder shall take all reasonable steps to ensure public safety; in particular, any vehicle or trailer used to assist in street trading shall be maintained in a safe condition and be tested / serviced annually.
- 35. The consent holder shall ensure that no waste liquids (including grease) of any description are deposited on to the site, highway or into rainwater gullies / drains serving the site. All liquids must be removed from the site and disposed of in a proper manner.
- 36. The consent holder shall take all reasonable steps to:
  - Prevent accumulation of litter dirt, and / or grease in or close to the site;
  - Remove and properly dispose of any such litter, etc which does accumulate.

- 37. No freestanding advertisements such as 'A' boards or signs attached to street furniture will be permitted.
- 38. The consent holder shall comply with any reasonable request and / or instruction given to him / her by a Police Officer or duly Authorised Officer of the Council.
- 39. The consent holder shall not use or permit to be used any electrical or electronic equipment (for example, televisions or radio receivers) in such a manner as to cause a disturbance and or nuisance.
- 40. The consent holder shall not obstruct the highway / footpath in which the site is situated or cause danger to persons using the highway / footpath.
- 41. The consent holder shall not cause nuisance or annoyance whether to persons using the street or otherwise.
- 42. The consent holder shall be responsible for and reimburse the Council in respect of any damage he / she causes to the highway / footpath or any fittings or fixtures on it.
- 43. The consent holder shall at all times obey all road traffic regulations in force in the consent area.
- 44. The consent holder and/or assistant must notify the Council immediately of any convictions or proceedings arising out of the use or enjoyment of the Consent, or from any other offence committed.

  - (c) The applicant/consent holder (or his/her nominated representative) will then be asked to:-

    - (ii) provide clarification on the application and respond to the representations made.
  - (d) The Chair of the Licensing Committee will invite Members of the Sub-Committee and all other parties present to put any relevant questions to the applicant and/or his/her representative.
  - (e) Consultees / interested parties will be invited to present their representations or elect a spokesperson (which may be a Councillor) to speak on their behalf. New representations must not be raised.
  - (f) The Chair of the Licensing Committee will invite Members of the Sub-Committee and all other parties present to put any relevant questions to the consultees / interested parties.
  - (g) The consultees / interested parties will be invited to sum up. A maximum of 5 minutes will be allowed.
  - (h) The applicant will be invited to sum up. A maximum of 5 minutes will be allowed.

## Appendix C

Strategic Transport, Sustainability and Infrastructure evidence and recommendation.

#### Clarkehouse Road, Sheffield

Summary of the traffic restrictions in relation to the area adjacent to the Botanical Gardens

#### **Background**

This note provides a summary of the yellow line waiting restrictions and other traffic restrictions that are present on Clarkehouse Road adjacent to the Sheffield Botanical Gardens entrance. It presents the changes to restrictions that have been made during 2019 and the reasons for this. It sets out at each stage the implications of the traffic restrictions on the ability for an ice-cream van to park in this location.

It then summarises work that has been undertaken to consider whether a space can be provided on Clarkehouse Road for an ice-cream van.

#### **Summary of Traffic Regulation Orders on Clarkehouse Road**

#### **Prior to the 2019 Traffic Regulation Order**

The area outside of the Botanical Gardens entrance has been covered by a double yellow line no waiting at any time restriction (preventing parking 24hrs a day 7 days a week), with a peak hour loading restriction (preventing loading between 08:00 to 09:30, 16:30 to 18:30), and zig zag markings on the approaches to the pedestrian crossing (preventing parking and loading at all times). This meant it was illegal for an ice-cream van to park on the double yellow lines or zig zag marking at any time.

To the west of the pedestrian crossing zig-zag markings on Clarkehouse Road, close to the entrance to the Botanical Gardens, there were single yellow line no waiting restrictions between 08:00 to 09:30, 16:30 to 18:30 on the Botanical Gardens side of the road. This meant that drivers, including the ice cream van, were able to park in this location outside of the times of the loading restriction.

These restrictions were consolidated into a Traffic Regulation Order in 2008 so these existed before 2008 however records are unclear as to when these restrictions were first introduced.

#### 1<sup>st</sup> 2019 Traffic Regulation Order (in effect from 09 May 2019)

As part of a wider scheme to improve conditions for cyclists along Clarkehouse Road all of the existing single yellow lines on Clarkehouse Road were changed into double yellow lines. As part of this change a 24 hour bus stand was provided in place of a section of the double yellow lines outside the Botanical Gardens entrance. This was provided to accommodate coaches and buses to local schools and the Botanical Gardens.

Note that only a bus can stop/wait at the bus stand, no loading or no blue badge parking is allowed.

This also means that it is illegal for an ice-cream van to park on the bus stand, double yellow lines or zig zag markings at any time.

#### 2<sup>nd</sup> 2019 Traffic Regulation Order (in effect from 07 October 2019)

Following implementation of the scheme in May 2019 a further Traffic Regulation Order was promoted to vary the bus stand restriction so that it only operates when required for the bus (14:30 to 16:00). In addition a no waiting single yellow line restriction was provided across the bus stand to operate outside of the bus stand time (Midnight to 14:30 and 16:00 to midnight). This was in response to calls from a local business and a blue badge holder about the impact the bus stand had on loading/unloading for businesses and blue badge parking for visitors to the Botanical Gardens.

Note that although a Traffic Regulation Order isn't required for a bus stand one is required to put a restriction in place for the times when the bus stand isn't operating.

The October 2019 changes mean it is still illegal for an ice-cream van to park on the bus stand, yellow lines or zig zag markings.

#### Important note

It should be noted that there is, as at today, a legal challenge to the validity of the October 2019 TRO based on an allegation of inadequate or unlawful consultation. That claim has yet to be determined but is being defended.

#### **Summary of restrictions**

Whilst changes have been made along Clarkehouse Road during 2019 in terms of the restrictions in place with both the previous and current TRO, it wasn't/isn't legal for the Ice Cream van to park on Clarkehouse Road outside the Botanical Gardens.

Since at least 2008 when the Consolidation Order was made, but in reality at some unknown date before this, no parking has been allowed adjacent to the Botanical Gardens entrance except from those vehicles parking with a valid blue badge, or those loading and unloading

### Consideration of whether space for an ice-cream van can be provided on Clarkehouse Road

Officers have considered whether a space can be accommodated on Clarkehouse Road adjacent to the Botanical gardens entrance.

The current bus stand is 19m long which is the recommended minimum length. It should be noted that the bus stand marking covers more than the space needed to park a coach (typically 12m long), it keeps the carriageway/kerbside clear of parked vehicles so that a coach can safely pull in and out of the stand.

An assessment as to whether a bay can be provided for an ice-cream van on Clarkehouse Road has been based on a 7m bay for ease of access as it could be difficult to get into a smaller bay if a bus was parked on the bus stand. A Short Wheel Base ice cream van is typically 5.3m long and a Long Wheel Base one is 5.8m long. This is shown on the plan in Appendix 1.

A 7m bay and a 19m Bus Stand cannot both be accommodated in front of the Botanical Gardens and as such the only way to accommodate a bay for an ice-cream van would be to either reduce the length of the Bus Stand below the

recommended minimum or to reduce the length of the zig-zag markings on the approach to the pedestrian crossing.

The requirement to provide 8 zig zag marks on the approach to pedestrian crossings is an important safety feature of pedestrian crossings as they maintain inter-visibility between drivers and crossing pedestrians. As mentioned earlier in this note, it is illegal (an endorsable offence, 3pts and up to a maximum fine of £1000) to park or stop on these markings. The number of zig-zags can be shorter than 8 marks on the approach to a crossing but only in certain circumstances (e.g. proximity of the crossing to a junction); however providing parking for vehicles isn't one of these.

A shorter Bus Stand marking is expected to compromise how a bus gets into it, making this a manoeuvre that would involve reversing back from the controlled area of the pedestrian crossing.

#### **Road Safety Auditor comment**

In considering the potential to accommodate a space on the carriageway for an icecream van due to the above constraints SCC's Road Safety Auditor was asked to comment on this issue.

These comments are repeated below:

As previously discussed I am concerned that an ice cream van in the space as shown would create problems for a bus/coach attempting to manoeuvre into the bus stand as it would prevent it entering the stand in one movement safely. A bus/coach would either be parked with its rear end sticking into the carriageway, which would block forward visibility to the crossing or, alternatively, would have to enter the bay by stopping on the zig zag markings and then reversing. This would also be dangerous as whilst the manoeuvre was taking place inter-visibility between pedestrians attempting to cross and drivers overtaking the manoeuvring bus/coach would be seriously compromised. In both scenarios visibility of the nearside traffic signal would be completely blocked to approaching drivers making overshoots of a red signal very likely and the situation considerably more dangerous for pedestrians. I believe that the latest Google Street View image from May 2019 amply demonstrates the visibility problems caused by a bus parked or manoeuvring within the zig zags, although given that the image was taken partly from the opposing lane visibility is actually slightly better than it would in practice (see attached).

I appreciate that buses currently sometimes do this at times under the current arrangement but by providing the layout as proposed the occurrence would happen far more often than at present and the Council would be actively promoting such dangerous behaviour.

It would be possible to allow a bus to access the stop by moving it south-westwards and reducing the number of zig-zags but this would be against DfT advice (which recommends a minimum of 8 zig-zags on the approach to crossings for visibility reasons) and, again, would compromise inter-visibility between pedestrians and approaching drivers, and the view to the nearside traffic signal.


All of the above scenarios will be made worse by the fact that, presumably, whilst buses are parked the crossing will also be at its busiest with schoolchildren using it on their route from school.

In summary, I consider providing a space for an ice cream van to park here to be dangerous and unwarranted (given that the ice cream van has previously always been parked on double yellow lines anyway) especially with the signals in their current configuration. Placing the nearside signal on a totem pole arrangement or, preferably, a mast arm would alleviate the forward visibility to the signals problem but would do little for pedestrian/driver inter-visibility. However, should you decide to proceed with providing a parking space for the ice cream van as proposed I would recommend that this be done, as a minimum, in order to at least partially mitigate for the increased road safety danger.

#### Conclusion

Based on the assessment undertaken and the Road Safety Auditors comments it is not recommended that the current Bus Stand arrangement is amended.

- 3. The Solicitor to the Committee will outline the procedure to be followed at the hearing.
- 4. Hearing Procedure:-
  - (a) The Licensing Officer will introduce the report.
  - (b) Questions concerning the report can be asked both by Members and the applicant.
  - (c) The applicant/consent holder (or his/her nominated representative) will then be asked to:-
    - (i) detail the application;
    - (ii) provide clarification on the application and respond to the representations made.
  - (d) The Chair of the Licensing Committee will invite Members of the Sub-Committee and all other parties present to put any relevant questions to the applicant and/or his/her representative.
  - (e) Consultees / interested parties will be invited to present their representations or elect a spokesperson (which may be a Councillor) to speak on their behalf. New representations must not be raised.
  - (f) The Chair of the Licensing Committee will invite Members of the Sub-Committee and all other parties present to put any relevant questions to the consultees / interested parties.
  - (g) The consultees / interested parties will be invited to sum up. A maximum of 5 minutes will be allowed.
  - (h) The applicant will be invited to sum up. A maximum of 5 minutes will be allowed.
  - (i) The Licensing Officer will then detail the options.
  - (j) There will then be a private session for Members to take legal advice and consider the application.
  - (k) Once a decision has been reached, all parties will be invited to return. The Sub-Committee's decision and reasons will be announced by the Chair.
  - (I) The Sub-Committee's decision will be confirmed in writing to the applicant and those parties who made representations.
- NB: 1) At any time in the Licensing Process Members of the Committee may request legal advice from the Solicitor to the Committee. This advice may be given in open session or in private.
  - 2) The Committee Hearing will be held in public unless and in accordance with the Regulations the Committee determine that the public should be excluded.

There is no right of appeal against the Council's decision to refuse to grant or revoke a Street Trading Consent.
