

The global humanitarian need continues to grow


70.8 million forcibly displaced people worldwide




Where the world's displaced people are being hosted

The Home Secretary reaffirmed the UK's commitment to resettlement post-2020





New global resettlement scheme:


A consolidated resettlement scheme, globally focussed with a new emergency mechanism



Community Sponsorship:


Becomes additional under the new scheme

- Since the scheme began in July 2016, 281 refugees have been resettled by community sponsor groups.
- พork and compassion of community groups and support of local authorities
- We hope making community sponsorship additional to our global commitment will encourage more groups to support refugee families.
- Local government will continue to play an important role in Community Sponsorship.



Mandate:

Remains additional under the new scheme



- The Mandate resettlement scheme resettles recognised refugees who have a close family member in the UK who is willing, and able, to accommodate them.
- Beneficiaries of the Mandate scheme must have been recognised as refugees by UNHCR and assessed by them to be in need of resettlement.
- Mandate will be additional to the main resettlement offer.
- The support arrangements are different under Mandate with the refugee accommodated and supported by a family member.

Summary

- From 2020 the new resettlement scheme will consolidate the Vulnerable Persons Resettlement Scheme, the Vulnerable Children's ના one global scheme. ઉત્તર The Lik Resettlement Scheme and the Gateway Protection Programme into
 - The UK will aim to resettle in the region of 5000 of the world's most \aleph vulnerable refugees in the first year of operation of the new scheme.
 - The 5 year £20,520 tariff for each refugee will be retained.
 - Refugees resettled by community sponsors will now be in addition to the government's resettlement offer.
 - A new process for emergency resettlement will be developed.
