Subject: Future Delivery of Youth Services

Decision Maker: Cabinet

Date of Decision: 17th June 2020

Decision to be removed from Call-in process:-

That Cabinet:

- a) Notes the appraisal of delivery options and approves the future delivery model for youth services as set out in this report.
- b) Approves the establishment of a cross-portfolio Project Board and Project Group to manage the end of the current contract and transfer relevant staff and services to the Council.
- c) To the extent not covered by existing delegations, delegates authority to the Executive Director of People Services to make the appropriate arrangements to bring the relevant services in house on 1st October 2020.
- d) Notes that this decision will be subject to the Leader taking into consideration any recommendations from the Children Young People and Family Support Scrutiny and Policy Development Committee.

Reasons for Urgency

The decision being recommended to Cabinet is that youth services are insourced. The current contract is due to expire on 30th September and so the insourcing process will need to be finalised by that date. The Cabinet decision therefore needs to be implemented promptly to allow sufficient time for the Council and Sheffield Futures to comply with their obligations to inform and consult in accordance with TUPE, to reduce the risk of service disruption and to ensure continuity of provision of statutory support and services to young people.

An earlier decision on the strategic direction for youth services is currently going through the Scrutiny process and the further information in this Report is due to be considered by the Children, Young People and Family Support Scrutiny and Policy Development Committee as part of that process. The recommendations arising from that consideration will be taken into account prior to implementation of the decision.
