Reasons for Urgency

The Household Waste Recycling Sites change to their summer opening hours on 1st April. If this decision cannot be implemented such that the change to the opening hours comes into effect at the same time as the move to the summer opening hours it will cause disruption for Veolia, who operate the sites, and confusion for members of the public. It is not in anybody's interests that the opening hours of the sites change twice within the space of a few days. Veolia also need time to implement the change, including making changes to employee terms and conditions.
