A clean, green and safe city centre with quality public spaces, and spaces for people to meet, socialise and relax


Workers

Heart of the City

- £470m development backed by the City Council
- 1.5m sq ft of development across 7 hectares
- 7000 new jobs
- New public park and public realm





Planning & Local Plan

Why we need a Local Plan

- Guides future development in the city – enabling more sustainable patterns of development
- Enables us to set better design standards – e.g. space standards, carbon reduction, biodiversity net gain
- Protects important green space and countryside from unplanned development
- Safeguards heritage assets
- Ensures land is provided for new homes – sets requirements for type/mix/affordability
- Provides and safeguards land for jobs – economic growth
- Reinforces the role and viability of the city centre, district centres and local centres
- Helps ensure more consistent decision-making
- Provides certainty for developers and investors

Puts the Council and local people in the ‘driving seat’ rather than national Government

Local Plan – Progress

Spatial option agreed by full Council in early 2022 and a draft Plan is being produced for public consultation based on this strategy




Sheffield's Transport Ambition

- Improved public transport
 - Faster, easier and more reliable bus network
 - Mass Transit Tram Vision: City and Regional
 - Responding to the challenges from Covid impacts
 - High Speed Connectivity Leeds and Manchester
- Improved cycling and walking networks
 - Routes that are safe and attractive
 - Providing 'healthy streets' and active neighbourhoods
- Support connectivity to growth areas
 - Sustainable capacity for growth
- Air Quality improvements – Clean Air Zone
- Supporting the decarbonisation of transport
- Improving accessibility and reducing inequality



Sheffield Net Zero 2030

- Our Pathway to Decarbonisation has been identified
- Our 10 Point Plan provides a framework for the Council's commitment to action
- Clear citywide benefits provided by taking action on the climate emergency, including:
 - improving health and wellbeing through, for example, reducing air pollution, enabling healthier lifestyles and choices and improving housing standards;
 - developing a sustainable economy fit for the future that is coming
 - generating wealth in communities and protecting people against fuel increases, for instance through increasing community renewable energy
- A key action over the next 12 months is producing our decarbonisation routemaps with clear actions for delivery.
