The opportunity has been opened to all community groups in Sheffield, and has been distributed via the Local Area Committees, via the councils community networks and partnerships, as well as through a media release. The council has no further funding to invest into any projects that express an interest in the containers, so community groups must have, or raise, any funding needed themselves. The proposal to provide the containers to the identified community groups promises numerous positive equality impacts.
