

#### 1.0 PURPOSE OF REPORT

1.1 To consider an application for the grant of a premises licence made under section 17 of the Licensing Act 2003.

#### 2.0 THE APPLICATION

- 2.1 The applicant is Miss Justyna Maciezewska
- 2.2 The application, which was received on 6<sup>th</sup> March 2013, is attached to this report labelled Appendix 'A'. Blank pages have been omitted to save paper, but the original application will be available at the hearing.

- 3.2 These matters were originally listed for 13<sup>th</sup> May. The hearing was adjourned to allow the applicant and other parties to liaise further with regards to the application. Records of the further discussions between the parties are attached at Appendices B2 and C3-C5 respectively.
- 3.3 The applicant and representatives from 3.1 have been invited to attend the hearing. Copies of the front page of the notices are attached to this report labelled Appendix 'D'.

#### 4.0 FINANCIAL IMPLICATIONS

4.1 There are no specific financial implications arising from this application. However, additional costs may be incurred should the matter go to appeal. In such an eventuality it may not be possible to recover all these costs. The impact of these additional costs (if any) will be kept under review and may be subject of a further report during the year.

#### 5.0 THE LEGAL POSITION

- 5.1 The Licensing Act 2003 at section 4 (1) requires the Licensing Authority to carry out its functions with a view to promoting the Licensing Objectives which section 4(2) sets out as:
  - a) the prevention of crime and disorder,
  - b) public safety,
  - c) the prevention of public nuisance,
  - d) the protection of children from harm.

5.2 Section 4(3) of the Licensing Act also requires the Licensing Authority to have regard to the published statement of Licensing Policy and any guidance issued by the Secretary of State under section 182.

#### 6.0 HEARINGS REGULATIONS

- 6.1 Regulations governing hearings under the Licensing Act 2003 have been made by the Secretary of State.
- 6.2 The Licensing Authority has provided all parties with the information required in the Regulations to the 2003 Act as set out at Appendix 'D'.
- 6.3 Attached at Appendix 'D' is the following:
  - a) a copy of the Notice of Hearing;
  - b) the rights of a party provided in Regulations 15 and 16;
  - c) the consequences if a party does not attend or is not represented at the hearing
  - d) the procedure to be followed at the hearing.

#### 7.0 APPEALS

7.1 The Licensing Act 2003 section 181 and Schedule 5 makes provision for appeals to be made by the applicant and those making representations against decisions of the Licensing Authority, to the Magistrates' Court.

#### 8.0 RECOMMENDATIONS

8.1 That Members carefully consider the representations made and take such steps as the Sub Committee consider necessary for the promotion of the Licensing Objectives.

#### 9.0 OPTIONS OPEN TO THE COMMITTEE

- 9.1 To grant the premises licence in the terms requested.
- 9.2 To grant the premises licence with conditions.
- 9.3 To reject the whole or part of the application.



The reason for the Representation is stated below and I would ask the Licensing Authority to consider that, if the application is granted, the proposed conditions should be attached to the premises licence for the Protection of Children from Harm, under the Licensing Act 2003.

The applicant seeks to trade as a "bar/meeting place" where football matches will be screened, pre-packed food will be sold and alcohol will be on sale from 10:00 hours until 23:00 hours at weekends and from 12:00 hours until 23:00 hours during the week. I am concerned that the applicant has not included any safeguarding measures in the operating schedule to ensure that children and young people may only access the premises when the environment is family friendly. The main trade at the premises is for the sale and consumption of alcohol and if additional safeguarding measures are not included, children may be exposed to irresponsible or dangerous adult behaviour within an adult orientated environment.

I am therefore writing to propose that the following conditions are attached to the licence, if the application is granted by the Licensing Authority:

- The Challenge 25 proof of age scheme must include refusals records, signage and staff training records.
- 2. The designated premises supervisor or other such responsible person should be assigned to the role of Children's Safeguarding Coordinator. This person should act in compliance with the guidance and training provided by the Sheffield Safeguarding Children Board. (For information, I attach a description of this role and confirm that the Safeguarding Children Board provides free training to support staff assigned to this role.)
- 3. Children under the age of 16 years must be accompanied by a responsible adult at all times.

2. I provided you with an advice leaflet about general risk management and with a leaflet about child sexual exploitation at licensed premises at our meeting earlier today. Please refer to these when doing your risk assessment of the premises.

3. There are a number of documents to help you maintain systems in relation to your Challenge 25 scheme

to prevent underage drinking and proxy purchase.

4. I also attach a copy of the children's charter which we discussed. This is to help you your staff ensure that adults bringing children to your premises are aware of their supervisory and behavioural responsibilities.

We also discussed today your responsibilities as a Designated Premises Supervisor and we discussed the licence conditions that I have recommended and we agreed the following conditions listed below will be put to the Licensing Sub Committee for its consideration:

1. The Challenge 25 scheme must include a refusals register, signage must be displayed and staff training records must be maintained.

2. The designated premises supervisor, or other such responsible person, should be assigned to the role of children's Safeguarding Coordinator. This person should act in compliance with the guidance and training provided by the Sheffield Safeguarding Children Board.

3. Children under the age of 16 years must be accompanied and supervised by a responsible adult at all times. The Children's Charter or similar signage will be displayed to help staff enforce this.

4. Persons under the age of 18 years must be off the premises by 21:00 hours unless attending a private prebooked family type function when the premises is closed to the general public.

5. There shall be no 18<sup>th</sup> birthday parties, functions or similar events.

D4

15. Subject to regulations 14(2) and 25, a party may attend the hearing and may be assisted or represented by any person whether or not that person is legally qualified.

#### Representations and supporting information

16. At the hearing a party shall be entitled to -

- (a) in response to a point upon which the authority has given notice to a party that it will want clarification under regulation 7(1)(d), give further information in support of their application, representations or notice (as applicable),
- (b) if given permission by the authority, question any other party; and
- (c) address the authority

#### Failure of parties to attend the hearing

- 20. (1) If a party has informed the authority that he does not intend to attend or be represented at a hearing, the hearing may proceed in his absence.
  - (2) If a party who has not so indicated fails to attend or be represented at a hearing the authority may:—

- 2. The Chair of the Licensing Committee will introduce the Committee and ask officers to introduce themselves.
- The Chair will ask the applicants to formally introduce themselves.
- The Solicitor to the Committee will outline the procedure to be followed at the hearing.
- 5. Hearing Procedure:-
  - (a) The Licensing Officer will introduce the report.
  - (b) Questions concerning the report can be asked both by Members and the applicant.
  - (c) The Licensing Officer will introduce in turn representatives for the Responsible Authority and Interested Parties who will be asked to detail their relevant representations.
  - (d) Members may ask questions of those parties
  - (e) With the leave of the Chair the applicant or his representative may cross examine the representatives of the Responsible Authorities and Interested Parties.
  - (f) The applicant/licensee (or his/her nominated representative) will then be asked to:-
    - (i) detail the application;
    - (ii) provide clarification on the application and respond to the representations made.
  - (g) The applicant/licensee (or his/her nominated representative) may then be asked questions by members and with the leave of the Chair from the other parties present.
  - (h) The applicant will then be given the opportunity to sum up the application.
  - (i) The Licensing Officer will then detail the options.
  - There will then be a private session for members to take legal advice and consider the application.
- The decision of the Licensing Committee will be given in accordance with the requirements of the Licensing Act 2003 and regulations made there under.
- NB: 1) At any time in the Licensing Process Members of the Committee may request legal advice from the Solicitor to the Committee. This advice may be given in open session or in private.
  - The Committee Hearing will be held in public unless and in accordance with the Regulations the Committee determine that the public should be excluded.
