<p>Manchester Road/Glossop Road Enforcement</p> <p>This new allocation is to design and apply bus lane and loading and waiting restrictions on Glossop Road, Manchester Road and Brocco Bank to an enforceable standard. The project will improve the flow of buses. <p>Relocatable Camera Enforcement</p> <p>This is a variation to include the 13/14 budget and add new areas to the project. Voluntary Registration This project will register the titles of all Sheffield City Council assets with the Land Registry. There are approximately 15,000 unregistered property titles currently owned by the Council, with most of the Council's titles remaining unregistered. In some cases, it leads to the Council having to re-negotiate terms or lose reputation due to missing deeds and/or title issues. <p>being weakened or removed, the Council’s risk is that it is at the mercy of ‘land grab’/theft through not being notified of a third party’s application for title where the property is not registered. The project helps to identify and clarify the ownership of land (within a legal “deed packet”) this should be seen as adding value to that parcel of land. The project cost is substantially made up personnel time involved in project management and delivery. To be funded from the Corporate Resource Pool.</p>																											
<p>Office Accommodation Efficiency Strategy (‘Workplace’): This programme was founded to reduce the Council’s accommodation costs to deliver services more efficiently at a lower cost and help release resources for front line services. It will deliver substantial accommodation savings and is a key part of the Council’s cost reduction strategy to meet the challenging financial climate.</p> <p>The whole programme is funded via Prudential Borrowing (at 5%) over 10 years, with the capital and interest repayments being met by the Workplace Strategy budgets. The net effect of this redistribution of funding across the revised programme is <u>nil</u>. <p>- IT Workstream This project covers the IT costs associated with the delivery of the “Workplace” programme within the Council's Accommodation Strategy. Changes in the IT infrastructure are vital to enable staff to adopt flexible work-style practices. New software functionality to be purchased includes “follow-me” printing (where users can send prints to any machine on the network) and automatic telephone number re-routing, driven by computer logon, to the workstation at which the employee is working on the day enabling the employee to work at a different desk every day with existing equipment avoiding the need to buy new kit. <p>- Crystal Peaks This project was originally set up to increase the potential of the Council’s Crystal Peaks building to accommodate the required numbers of staff associated with the agreed Workplace Strategy. Due to reducing staff numbers within the Authority a review of the accommodation needs at this location has concluded that future demands can be met with the existing layout so no further expenditure is required. <p>Housing Investment Projects – Heating This programme has been approved in the 2013-14 Budget by Council on 1st March 2013. It will replace obsolete and inefficient heating systems with modern examples which will help the Council meet its environmental responsibilities and reduce maintenance costs.</p>	<p>Procurement Strategy</p>	<p>15,500</p>	<p>Competitive Tender</p>

<p>We propose to procure these works by means of competitive tendering processes. The Council wishes to support local, small businesses so it will offer two contracts worth approximately £0.95m per year for each of the next three years. These can be advertised locally in addition to usual sources, thus opening up the market to smaller players. The remainder of the work will be delivered through one further large contract worth approximately £9.8m. All works over £4.3m in value are subject to European procurement regulations and have to be advertised in the Official Journal of the European Union (OJEU). This will apply to the larger contract.</p> <p>The Council has established procedures to ensure that it discharges its duties under the Equalities Act. An Equality Impact Assessment has been completed and is available for scrutiny. We have also considered our duties under the Public Services (Social Value) Act and will discharge our duties by requiring Employment and Skills outcomes from the project. These will be refined as the specification for the project progresses and bidders will be required to set out their employment and skills proposals against these requirements (which will be reported at Contract Award stage). Offering two smaller contract packages which are more likely to fall within the capacity of smaller organisations in the area also helps us discharge our responsibilities under the Act.</p>			
<p>Norton Aerodrome This scheme, to acquire and clear the former aerodrome, was approved by Cabinet on 20th March 2013.
